



## Linda Michaluk Scholarship Fund

### PURPOSE OF FUND

The College of Applied Biology has established an endowment fund with the Victoria Foundation known as the **Linda Michaluk Scholarship Fund**. The purpose of the fund is to provide financial support to graduate students pursuing research in to the advancement of science-informed decision making, or to the development of laws and regulations that affect the practice of natural resource management.

In 2002 the Province of British Columbia read into Legislation the *College of Applied Biology Act*. In 2012 the founding Executive Director of the College, Linda Michaluk, RPBio, retired. She was instrumental in the process that created the College. In recognition of her exemplary service to the profession, the College of Applied Biology Council made a decision to honour Linda's work and commitment through the creation of the Linda Michaluk Scholarship Fund (LMSF), held at the Victoria Foundation. The LMSF demonstrates the College's commitment to further the development and implementation of laws and regulations that affect the practice of natural resource management. The LMSF is a scholarship of \$2,500 awarded annually to successful candidates.
